A DIRECTIVE FOR THE “HOME STAY OWNERS” AND “PRIVATELY OWNED COFFEE SHOPS” AT SITIO GUINTUBDAN, BARANGAY ARA-AL, LA CARLOTA CITY TO MAINTAIN A LOGBOOK FOR CONTACT TRACING PURPOSES

WHEREAS, Republic Act No. 11469 or the Bayanihan to Heal as One Act declaring the existence of national emergency arising from the Coronavirus 2019 (COVID 2019) situation with national policies to quell if not immediately eradicate the transmission of such disease or quell the same placing the whole Philippines under Enhanced Community Quarantine;

WHEREAS, the same Act declared the policy against COVID-19 pandemic that has affected loss of lives and disruption of the economy which will prevent social/local transmission by means of medical tests and treatments to persons under investigation (PUI) and persons under monitoring (PUMs);

WHEREAS, Republic Act No. 11494, An Act Providing for the Bayanihan to Recover As One (Bayanihan 2), or whole-of-government response to the second phase of the war against COVID-19, containing policies and measures to plan for economic recovery for the second phase of the National Action Plan (NAP) in order to reduce adverse socio-economic impact of COVID-19 and enhance the capacity of the Philippine health care system to control and eliminate COVID-19 through strict compliance to Health and Safety protocols;

NOW, THEREFORE, I, REX R. JALANDO-ON, City Mayor of La Carlota City, hereby order the following guideline formulated herein for compliance of the “Home-Stay Owners” and the “Privately Owned Coffee Shops” at Sitio Guintubdan, Brgy. Ara-al, La Carlota City in the task of accommodating guests/visitors coming from outside the City.

Section 01. The “Home Stay Owners” and the “Privately Owned Coffee Shops” shall provide and prepare a system of accurate and timely documentation in accepting guests/visitors through the use of logbooks in their respective areas.

Section 02. The “Home Stay Owners” shall require the guest/visitor to provide the following documents upon check in:

- a. Certification from the place of origin (Barangay Certification) stating that the he/she has never been considered as a Person Under Investigation(PUI)/Person Under Monitoring (PUM); and
- b. Medical Certificate from the City Health Office where he/she permanently resides.

Section 03. Effectivity. This order shall take effect immediately upon its signing.
